

NOTE: THE COMPETITION IS REGIONAL COVERING UK AND IRELAND ONLY

1. Competition: "Closest to Pin – Mount Juliet" play Hole #3 – 113 yard at Mount Juliet Estate

2. Promoter: The Competition is organized and promoted by "Mount Juliet Estates".

3. Participation Period: The Competitions commences at 12:00 AM GMT (Greenwich Mean Time) on 1 June, 2025, and ends at 11:59 PM GMT (Greenwich Mean Time) on 30 June, 2025 ("<u>Participation Period</u>").

4. Eligibility: The Competition is open to persons who are: (i) legally and physically residing in the UK and Ireland; and (ii) at least eighteen (18) years of age during the Participation Period.

Employees, agents or directors (or their respective family members) of Mount Juliet, Toptracer or any related companies ("<u>Competition Entities</u>") may participate in the Competitions but are not eligible to win prizes.

By participating in a Competition, Participants agree to be bound by these Official Rules and confirm that they meet the eligibility criteria.

5. Competitions Overview: The Competitions take place at all participating Toptracer Range locations in the UK and Ireland (each a "<u>Venue</u>" and collectively "<u>Venues</u>"). To participate in a Competition, each Participant must (i) download the free Toptracer Range mobile app (the "<u>App</u>"); (ii) sign in to your existing account or create a new account; and (iii) register for the Competition via the unique QR code or link available on the Toptracer website and social media.

How it works:

- Visit your local Venue and buy a bucket of balls or hire a bay in line with the Venue's policies.
- Connect your profile to the bay screen using the App on your phone.
- Select the Competition as shown on the screen and start playing! You can play as many times as you like.
- The Competition is a classic "Closest to the Pin" on Mount Juliet Championship Course, Hole #3 – 113 yards.

6. Prizes

- **1**st **PLACE MALE** Overnight stay for 2 Guests at Mount Juliet including Breakfast plus 1 Round of golf for 2 Guests
- **1st PLACE FEMALE** Overnight stay for 2 Guests at Mount Juliet including Breakfast plus 1 Round of golf for 2 Guests

(Approx Retail Value of each prize: €550

In the event of a tie (for example if there are multiple holes-in-one ("HIOs")), the winner will be determined as follows:

- If multiple HIOs, the Participant with most HIOs
- If matching scores (or matching number of HIOs), the Participant achieving their result first.

General Information*

Prize is valid for stays Sunday to Thursday and is subject to availability (certain date restrictions may apply) and must be redeemed by 31st December 2025 (no exceptions). Prize includes accommodation, golf green fee and breakfast only – no travel, other meals, caddie, buggy or trolley fees, gratuities or other costs are included. All golfers must have a valid handicap. Prizes are enjoyed subject to Promoter's other terms as can be found here https://www.mountjuliet.ie/golf/visitor-information/ or as otherwise provided to winner.

Prizes are non-exchangeable, non-transferable and no alternative will be offered, including in circumstances where the winner (or travel companion) is unable or unwilling to travel for any reason. Winners are responsible for having valid travel documents (including visa/passport as required).

7. Prize Administration: Promoter will attempt to contact winners via their registered email within 30 days of conclusion of the Competition. If a potential Winner cannot be reached directly within a further 7 days, does not meet the eligibility requirements and/or is unable or unwilling to accept a Prize (including due to amateur status), then, at Promoter's discretion, the next placed Participant will be awarded the Prize.

The prize will be arranged over email in communication with the Promoter.

In certain jurisdictions Prizes may be subject to taxes. All federal, state and local taxes, customs duties and any other costs and expenses associated with acceptance or use of a Prize are solely the Winner's responsibility, but Promoter has the right to withhold any amounts required by law. Winners shall complete any applicable tax forms as required in their local territory.

Where it is a legal requirement, Promoter will provide a list of winners and this can be requested from the details at the end of these rules.

8. Data Privacy:

When registering and participating in the Competition, you acknowledge that Toptracer's <u>privacy policy</u> applies, and that your username may be published on public leaderboards relating to the Competition which will feature on the App, Toptracer and the Promoter's social media and elsewhere. Further, you acknowledge that your information (Username, contact

details and other profile details as well as your Competition performance) will be shared with the Promoter who will then be a separate "controller" of your information and will process your information in accordance with its own privacy policy: <u>https://www.mountjuliet.ie/privacypolicy/</u>. If you win a prize your details will be used by the Promoter for prize fulfilment and related purposes accordance with the privacy policy. Your username and other profile information may also be publicized by Mount Juliet Estate on social media and elsewhere. This may include, for example, if you win the Competition, have a high score or your participation is otherwise noteworthy. Additionally, Mount Juliet Estate may invite you to participate in photo, recording, video and/or filming session(s) upon visiting to redeem your prize.

9. General Terms:

- a) Competition Entities are not responsible, and shall have no liability, if a Competition cannot take place, is disrupted, if any Prize cannot be awarded, accepted or fully enjoyed, or your participation or registration is prevented or disrupted due to (i) acts of God, war, natural disasters, weather, pandemic, acts or threats of terrorism, strikes, lockouts, labor disputes, work stoppages, fire, power cuts, acts of government, other events outside of the reasonable control of Competition Entities; (ii) due to any computer virus, bugs, tampering, unauthorized intervention, fraud, downtime, outages, technical failures or human or computer error; (iii) acts or omissions of any Venue, including closures or unavailability; (iv) acts or omissions of any other third-party; (v) any actual or perceived technical issues with the Toptracer system where a shot played during the Competition is not traced, or is traced incorrectly.
- b) If, for any reason outlined above, the Competition is not capable of running as planned, Promoter reserves the right, in its sole discretion, to cancel, terminate, modify, or suspend the Competition. If the Competition is terminated or modified prior to the end date of the Competition, notice will be posted on Promoter social media accounts. In such circumstances Promoter shall be entitled at its sole discretion to either (i) declare a Competition null and void, or (ii) declare winners from those of have already participated.
- c) Where a Prize (or any part thereof) is deemed invalid or unlawful (other than for reasons stated under 9a) in any territory then Promoter shall be entitled to offer the winner a valid alternative, which may be of lesser value.
- d) Golf equipment used during Competition must meet Equipment Rules as provided in Appendix II of the Rules of Golf; any Participant using "illegal" equipment will be eliminated from Competition.
- e) Participants must be logged in to their own profile and the same participant must complete the entire Competition. Using other users log-ins, or participating jointly is not permitted and any participants doing so will be eliminated from the Competition.
- f) The Competition is organized and promoted by Mount Juliet Estate but entry to and participation in the Competition is subject always to availability at your local Venue (please check your local Venue is open and running the Competition before visiting!). Venues are independent from the Competition Entities and set their own policies, opening times and availability, which you are required to follow. To enter the competition, you are required to purchase balls, bay time or otherwise access the Venue in line with its policies.
- g) These Rules are supplemental to Toptracer's standard participation terms for events as displayed in the App when registering for the Competition. In the event of any conflict, these Rules prevail.

 h) Promoter is the sole organizer and promoter of the competition. While the competition is "Powered by Toptracer" and is run on the Toptracer platform which can be accessed at Venues, neither Toptracer nor the Venues are promoters or organizers of the competition, and they have no liability under these Rules or otherwise in relation to the competition and you agree not to bring any claim against them.
